Kani City Local Currency “K Money” Partner Store

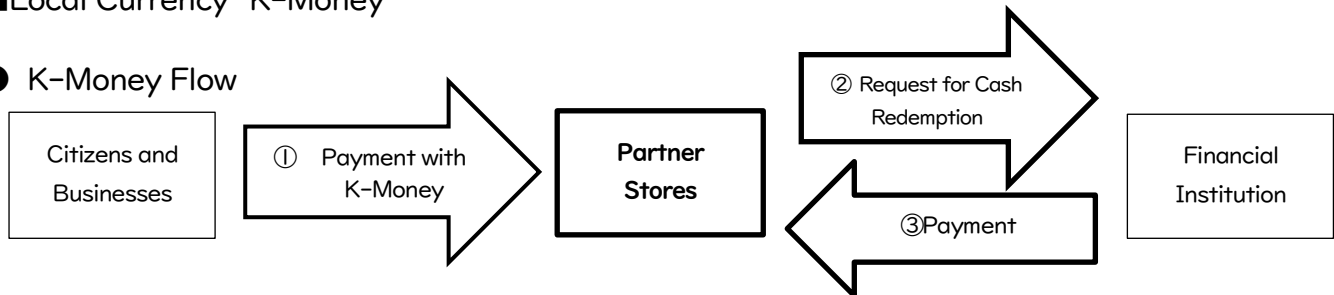
On behalf of city administration, Kani Chamber of Commerce & Industry is seeking businesses that are willing to accept “K-Money” currency, as a form of payment for their goods and services.

“Kani City Local Currency K-Money” system is a city initiative designed to **support a society facing a declining birthrate and aging population, while revitalizing the local economy through the collaborative efforts of citizens, businesses and the city administration.**

Therefore, we would like owners to view this initiative as an opportunity for social contribution and sales boost, as described below.

■Local Currency "K-Money"

● K-Money Flow



K-Money received from customers should be converted into cash at a registered redemption financial institution. After the deduction of the social contribution fee* (1% of the total amount), the remaining balance will be transferred to the store redemption account in the second business day following the transaction.

※Although the 1% for social contribution is suspended since May 1, 2020, the collected social fee will be redirected to “K-money” operational and volunteers support funds.

●Premium Benefits

Benefits are store giveaways (eg.: double points, complimentary desserts etc.) offered exclusively to “K-Money” users. By offering stores unique premium benefits, they can enhance their appeal and increase customer traffic. More than 30% of all current partner stores offer some kind of premium benefits.

Remarks: Each store determines their giveaway type. Premium benefits details will be posted on city website.

■Application for partner store registration

●Period: anytime

●Requirements

Owners must meet all the following conditions:

- ① Businesses with branch(es) in Kani City
- ② Businesses that do not violate public order and morals

●Application Method

Fax or mail the “Registration Form” to Kani Chamber of Commerce & Industry (*Shouko Kaigisho*)

●Additional information

1. Once the application form is received, a “Registration Approval Notice and Materials for Partner Stores” will be mailed to the owner.

※Stores can begin handling “K-Money” upon arrival of the above-mentioned notice.

2. After registration approval, the update of redemption accounts, website, flyers etc. will be processed according to the following.

①Forms received by the 20th of each month: update will be performed on the 1st of the following month.

② Forms received by the 5th of each month: updated will occur on the 15th of the same month.

- If registration request is made on a Saturday, Sunday or holiday, it will be processed on the next business day.
- Cash conversion can only be accepted after the above-mentioned update.

■Necessary information for registration

- ・ One (1) form is required for a single or multiple stores. However, if the owner is willing to set a different account to each store (in case of multiple stores), it will be required one form per store.
- ・ Store e-mail address is necessary to receive notifications/information regarding “K-Money” .
- ・ Redemption accounts are available at branches or sub-branches of financial institutions designated by Kani City.
- ・ Account holder's name should be entered according to the one printed in the bank book.
